6. Cookies

Any natural or legal person that logs on to the Website is considered as a User of the latter. By accessing the Website, Users acknowledge that they have read and accept all the present General Conditions of Use.

The functionalities of the Website require processing the personal data of Users (hereinafter referred to as "Personal Data").

As the editor of the Website, Expertise France reserves the right to modify the content of the present General Conditions of Use at any time, without prior notice or notification. Consequently, Users are recommended to regularly consult these General Conditions of Use.

Expertise France undertakes to ensure that this processing complies with the legal and regulatory framework (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data.

6.1. Website cookies and third-party cookies

Website cookies

The Use of the Website requires the use of traffic log cookies.

Cookies refer to tracers that provide access to the Users' information already stored in the equipment they use as an electronic communications terminal and record information on it.

The Personal Data collected in this manner are used to produce Website traffic statistics and obtain information about the browsing paths of Users on the Website. The purpose is to assess the interest of Internet users in the Website and the content.

The Personal Data collected from the Website are communicated and processed by Expertise France's Communication Unit.



Expertise France undertakes not to use Personal Data for purposes other than those mentioned above in order to ensure their confidentiality.

Google Analytics and Google Tag Manager cookies

The Website uses Google Analytics, a website analysis service provided by Google LLC ("Google"). Google Analytics uses cookies, which are text files placed on your computer, to help the Website analyse its use by its Users. The data generated by the cookies concerning your use of the Website (including your IP address) will be transmitted and stored by Google on servers located in the USA. Google will use this information to assess your use of the Website, compile reports on the Website's activity for its editor, and provide other services relating to the Website's activity and use of internet. Google may transfer this information to third parties where required by law or when these third parties process this data on behalf of Google, including the editor of this Website. Google will not associate your IP address with any other data held by Google. You may disable the use of cookies by selecting the appropriate settings on your browser. However, such deactivation may disable the use of certain functionalities of the Website. By using this Website, you expressly consent to the processing of your personal data by Google in the manner and for the purposes described above.

Cookies used:

- _ga: cookie used to identify individual Users of the domain. It expires after 2 years.
- _gid: cookie used to identify individual Users of the domain. It expires after 24 hours.
- _gat: cookie used to limit the number of User requests in order to maintain the performance of the Website. It expires after 1 minute.
- AMP_TOKEN: cookie containing a unique identifier attributed to each User of the domain. It expires between 30 seconds and 1 year.
- _gac_<property-id>: cookie containing a unique identifier that allows Google Analytics and ads to function together. It expires after 90 days.

Third-Party cookies

Facebook, Twitter, LinkedIn, and YouTube may use cookies required to view or share content on social networks or produce access statistics.

The presence, number, and status of these cookies may depend on your use of the platforms in question before or during your visit to the Website.

Expertise France has no control over the use of these functionalities by these actors. We invite you to read the management policy for these social network cookies on the websites in question.

6.2. Management of cookies

You may accept or refuse the deposit or reading of cookies at any time by:

- Refusing the cookies when you first visit the Website.
- Setting your browser to disable or accept cookies.
- Setting your browser to be notified of the deposit of cookies in order to be able to specifically accept and refuse them.



In accordance with the amended French "Data Protection Act" n° 78-17 of 6 January 1978 and European regulation 2016/679, you may, at any time, exercise your rights to access, rectify, erase, and portability of the information concerning you, as well as your rights to limit and oppose the processing of your data.
