The context

As outlined in the latest global biodiversity outlook (GBO4), the world is not on track to achieve the Aichi targets. Efforts have increased but are not sufficient to meet global targets and biodiversity is still being lost at an unprecedented rate. Development is still unsustainable and pressures on biodiversity have increased significantly.

The current Strategic Plan was hailed as a success when adopted in 2010 as it raised the level of ambition for biodiversity. It has, however, shown various weaknesses in its implementation phase.

What are the lessons learnt from the preparations and diplomatic achievements in international environmental and sustainable development negotiations (climate, desertification, SDGs,...) to reach an ambitious and effective follow-up to the Strategic Plan for Biodiversity?

To support the process of achieving a comprehensive and high-reaching agreement at CBD COP15, there is an urgent need to initiate partnerships to explore cooperation opportunities among major stakeholders.

"Follow-up to the Strategic Plan for Biodiversity 2011-2020", a project funded by the European Commission, is specifically designed to support and accompany non-EU States in the process of formulating transformational ambitions in the run-up to COP15.
