The EnMAR - *Enhanced MARitime Action in the Gulf of Guinea* - project, funded by the European Union (EU) and implemented by Expertise France, aims to **improve maritime security and economic prosperity in the Gulf of Guinea (GoG)**, in support of initiatives undertaken by the EU, including the **Coordinated Maritime Presences (CMP)**.

EnMAR contributes to **foster political dialogue, cooperation and exchanges** with key partners of the Yaoundé Architecture and with European and international actors, in order to develop **appropriate and effective EU action** in the region. EnMAR's activities are related to the **EU's Maritime Strategy for the Gulf of Guinea** and **enhance the visibility** of the support provided to regional stakeholders.

## Our objectives and activities

► **PROMOTE political dialogue and involvement** of various actors in the Gulf of Guinea on maritime security

EnMAR supports **high-level political and operational initiatives** by providing **technical expertise**, as well as a **logistical and financial support**

International forums (G7++ Friends of the Gulf of Guinea, symposium of Chiefs of regional navies), events organised with EU Delegations and in the framework of CMP stopovers (workshops on maritime security, seminars, high-level meetings), etc.

► **IMPROVE the relevance and coherence** of EU initiatives on maritime security and safety

EnMAR facilitates **knowledge sharing and coordination** between European initiatives, in order to promote **synergies** and identify **new actions to be developed**

Organisation of regular meetings between various EU-funded projects in the field of maritime security and safety in the GoG, and information-sharing and coordination for the benefit of the EU Delegations in the region, in liaison with the Senior Maritime Security Coordinator of the EU's European External Action Service (EEAS).

► **STRENGTHEN the operational capacities** of national and regional institutional partners on maritime security and safety

EnMAR organises **training courses**, participates in **workshops** and provides **tailored-made expertise** on maritime security and safety topics

Regional trainings for ports, technical sessions on Maritime Domain Awareness (MDA), development of maritime crisis management scenarios.

► **RAISING awareness** of EU action on maritime security in the Gulf of Guinea

EnMAR implements a **public diplomacy and visibility** strategy **promoting the European Union's action** with regional and international partners, through the dissemination of key messages, participation in events, and creation of digital communication tools and visibility materials

Participation in international events, support to press and communication services of the EU Delegations, organisation of conferences, presence on social media, production of videos and podcasts, information monitoring and creation of visibility materials.
